SPECIAL DISTRICT SPOTLIGHT

4S Ranch Water Reclamation Facility

Olivenhain Municipal Water District's



In the late 1980s San Diego County was experiencing exceptional population growth, and it was during this time that the first portion of 4S Ranch was developed. The county built a small wastewater plant to serve the sanitation needs of the new development. In 1998, Olivenhain Municipal Water District annexed the 4S Ranch and Rancho Cielo Sanitation Districts from the county. It was at that time that OMWD took ownership of the 4S Ranch Wastewater Treatment Facility. In its original capacity, this treatment facility had the capability to treat a small amount of wastewater from the surrounding commercial center and condominium complex. The wastewater was treated and disposed by spraying on the surrounding unimproved pastureland.

However, future development plans for that area included the addition of thousands of new homes. The existing small wastewater plant would not be able to treat the increased flows from a growing population. OMWD undertook an expansion project to increase the original capacity of the facility to 2 million gallons per day. recognizing the need for increased local water supply, OMWD incorporated sand filtration and UV disinfection to meet recycled water quality standards. OMWD required developers to install recycled water support infrastructure as part of the residential and commercial development within the region, and in August of 2003, the final approval was granted to produce and sell recycled water from the 4S Ranch Water Reclamation Facility.

Treatment Process

Wastewater entering 4S WRF undergoes a



tertiary, or three-stage, treatment process. The primary stage involves straining out debris such as dirt, rocks, and plastics from the incoming wastewater. During this stage, an odor scrubber is employed to allow the remaining treatment process to take place odor-free. Secondary treatment utilizes biological microorganisms that break down organic material within the wastewater, followed by the settling and separating of solids for further processing. Finally, the tertiary stage further purifies and disinfects the water using both sand filtration and UV disinfection before the treated water is released into the recycled water distribution system.

Economical and Environmentally Sound

The use of recycled water is both economically and environmentally The San Diego region is responsible. largely dependent on water from faraway sources to meet its water use demands. With a growing population and climate uncertainty, developing a drought-resilient supply is essential. While much of the wastewater within the County is treated and

Treasurer's Report

January 1, 2018 through March 31, 2018

Income for the period was from the November 2017 dinner meeting \$720.00 and February 2018 dinner meeting \$2,020.00 (67 attendees) for a total of **\$2,740.00**.

Expenditures for the period included Butcher Shop Restaurant for February 2018 dinner meeting \$2,577.79 and Weebly for video contest website hosting \$152.38 for a total of **\$2,730.17**.

"Friendly amendments" are horrid!

Encourage your board or local government to refrain from the unfortunate practice of using "friendly amendments." Many people think that if they offer a "friendly amendment," the maker of the motion and the seconder can accept it. This is wrong. Once a motion is made, seconded, and stated by the chair, it belongs to the whole group. Any proposed amendment, whatever its intent, must be considered by the group as a whole. It is the group that will either accept or reject it.

Read about friendly amendment in Robert's Rules of Order Robert's Rules of Order Newly Revised, 11th edition, the most widely accepted authority on parliamentary procedure, offers a clear discussion of this issue on page 162, lines 9-19. The section is entitled "Friendly Amendments."

Greetings CSDA members!

discharged to the ocean for disposal, OMWD sees the benefit of reclaiming wastewater and providing it for beneficial reuse, rather than disposing of it.

4S WRF is a zero liquid discharge facility, meaning that every drop of water treated at the facility is reused, and every drop of water that is reused, conserves precious drinking water. An added benefit to using recycled water is that the recycled water is produced locally allowing it to be sold at a cost that is about 15% less than the cost of potable water. This can add up to big savings for irrigation and commercial customers.

Who it Serves

4S WRF collects wastewater from the 4S Ranch community in San Diego as well as neighboring Rancho Cielo. The water generated at the facility is delivered to irrigation customers throughout 4S Ranch including homeowner associations, schools, parks, and golf courses. In addition, OMWD operates an innovative recycled water fill station providing free recycled water for residential customers to use for their own landscape irrigation.

The reclamation facility is but one component of OMWD's larger recycled water system. OMWD serves recycled water to additional regions within its service area by procuring recycled water from its partners including San Elijo Joint Powers Authority, Vallecitos Water District, City of San Diego, and Rancho Santa Fe Community Services District. Overall, about 12 percent of OMWD's water demands are met with recycled water.

Awards and Community Involvement

Since its expansion, the facility has won several awards for its design, recycled water advocacy, and superior




operations practices. Recently 4S WRF received two awards for its exemplary safety record: the Water Environment Federation's George W. Burke Award and the "Safety Small Plant of the Year" award from the California Water Environment Association.

OMWD staff takes great pride in their facility and regularly educates visitors on the benefits of recycled water during public tours, field trips, and its annual open house event in August.

About Olivenhain Municipal Water District

Incorporated in 1959, OMWD is a special district that provides water, wastewater services, recycled water, hydroelectricity, and the operation of Elfin Forest Recreational Reserve. With a service area of over 48 square miles, OMWD serves approximately 86,000 customers in Encinitas, Carlsbad, San Diego, San Marcos, Solana Beach, and neighboring communities.

Unanimous Consent Will Slash - - - Your Meeting Time - - - -



Unanimous consent is one of the most useful tools in Robert's Rules of order. Yet this method of voting is little known. Use it well, and your meetings will be much more efficient. Your members will also be grateful!

Unanimous consent is a kind of "fast track" for voting. The chair proposes a given action, and then says, "Is there any objection?" If a member agrees, she REMAINS SILENT. In this instance, silence means consent. If all members are silent, they have agreed to the action proposed.

If a member disagrees, he simply says, "OBJECTION" or "I OBJECT." The chair then knows that everyone is not in agreement, and proceeds to take a vote in the usual way. Note that there is no need to explain WHY you object. All you have to do is alert the chair that you don't agree.
